## **8. Donor Privacy Policy (Required to post on website or make available in station)**

KCUW Radio is barred from renting contributor names, donor names, or other personally identifiable information (collectively, Personal Information) to or from, or exchanging Personal Information with, any Federal, state, or local candidate, political party, or political committee.

KCUW Radio is also barred, unless required by law, from disclosing a contributor or donor's Personal Information to any Nonaffiliated Third Party, unless the station:

- a. clearly and conspicuously notifies the contributor or donor that the station may release its Personal Information to Nonaffiliated Third Parties;
- b. advises contributors or donors before any disclosure that they have the option not to have their Personal Information disclosed; and
- c. explains to the contributor or donor how to exercise that non-disclosure option.
